Area of application (hereinafter also referred to as "premises"):

Rathausplatz in the entire area between Rathaus and Burgtheater as well as in the fenced area of Rathauspark Period of validity: 12.6.2019, 07:00 - 15.6.2019, 24:00

> and Sigmund-Freud-Park Period of validity: 14.6.2019, 07:00 - 15.6.2019, 24:00

ACCESS CHECKS

CHECKS BY THE SECURITY SERVICE

Any person entering the premises within the scope of these house and site rules expressly declares that they are in agreement with any check carried out by the organizer's security services. Security service instructions have to be followed without restrictions, otherwise access will be denied.

The security service employed is entitled to check persons to see whether they pose a security risk due to alcohol or drug consumption, or because they are carrying weapons or dangerous objects. The visitor declares that they expressly agree that their clothing and any containers they may carry with them may be searched to that effect.

The security service is authorized to deny access to persons who pose a security risk to the premises. The same shall apply to persons who refuse to give their consent to the search of their clothing and containers.

The security service is also entitled to carry out such checks on persons who are already on the premises. In the event of violations of the house rules, the organiser is entitled to expel the offenders from the premises.

Children under the age of 14 are only allowed to enter the premises if accompanied by an accompanying person pursuant to the current version of the Viennese Youth Protection Act (Wr. Jugendschutzgesetz).

In the event of a violation of these house and site regulations, the security service is permitted to verify the identity of the persons involved.

FORBIDDEN OBJECTS

It is prohibited to carry weapons of any kind, objects that can be used as a weapon as well as objects and substances which could pose a hazard to the environment, pyrotechnic articles of any kind and flammable liquids, alcoholic beverages, cans, glass bottles, drugs and other intoxicants, racist, xenophobic, Nazi, sexist or political propaganda materials and any objects and materials used for advertising purposes (commercial, political or religious).

It is also forbidden to take along objects that cause undue noise and might pose a health risk to other visitors. The organiser defines as unduly noisy objects, which generate noise higher than 80 decibels (dB).

In case of doubt, the classification of objects as forbidden or permitted in the sense of these house and site rules is up to the responsible security service employee.

Access to the premises will be denied to persons who are carrying prohibited objects pursuant to these house and site rules. If persons with forbidden objects are encountered on the premises, the security service is entitled to confiscate said objects without compensation.

The carrying along of animals, with the exception of guide dogs for the blind and assistance dogs, is prohibited. Those must wear a harness.

BEHAVIOUR IN EMERGENCIES

BEHAVIOUR IN EMERGENCIES

In case of danger (fire, accidents, suspicious objects or persons, fight, etc.), the security service or the emergency forces of the blue light organisations must be informed immediately.

BEHAVIOUR IN THE EVENT OF SEVERE WEATHER (STORM; HAIL; THUNDERSTORM)

It is expressly pointed out that in the event of severe weather, related organiser instructions (instructions given by the security service, announcements via the sound systems) must be observed. In particular, staying under trees as well as staying in the immediate vicinity of technical facility structures can pose a hazard. Organiser information in this regard (instructions by security service, announcements via the sound systems) must be observed.

BEHAVIOUR DURING AN EVACUATION

In case of a necessary evacuation, it is absolutely necessary to keep calm and to follow the instructions of the organiser, the security service, the emergency forces of the blue light organisations and announcements unconditionally.

Should there be a threat of overcrowding of parts of the event premises, it may be necessary to implement access restrictions.

ALCOHOL

NO ALCOHOL MAY BE CONSUMED BY VISITORS BELOW THE AGE OF 16; NO DESTILLED ALCOHOL MAY BE CONSUMED BY VISITORS BELOW THE AGE OF 18; NO ALCOHOLIC BE-VERAGES MAY BE TAKEN ONTO THE PREMISES BY VISITORS.

Pursuant to § 11a of the current version of the Viennese Youth Protection Act (Wr JSCHG i.d.g.F.), it is prohibited for persons up to the age of 16 to purchase and/or consume alcoholic beverages in publicly accessible places and/or during public events.

Persons up to the age of 18 are not permitted to purchase and/or consume alcoholic beverages that contain distilled alcohol, in places accessible to the general public and/or during public events.

In this context, the organiser expressly reserves the right of employees and the authorities to conduct checks. Any contravention will be reported, alcoholic beverages will be confiscated.

It is prohibited to bring alcoholic beverages in bottles to the event premises. Any containers of this kind will be confiscated without compensation. Pursuant to these regulations, the visitor declares their agreement to appropriate checks conducted by employees of the organiser.

Excessive consumption of alcohol on the event premises is prohibited. The organiser reserves the right to expel from the event premises persons who are heavily intoxicated and who represent a danger to themselves and/or third parties.

BAN ON DRIVING

There is a general ban on single-lane and multi-lane motorised vehicles on the entire premises.

Driving on the premises is only permitted with the express permission of the organiser and may only be carried out with extreme caution and at a maximum speed of 15 km/h.

LIGHTING

The area is illuminated via the public electricity network only during the night hours.

REINIGUNG

The cleaning of the premises will take place after the end of the event.

LEGAL CONSEQUENCES

VIOLATIONS OF THE HOUSE AND SITE RULES OR OTHER VIOLATIONS OF THE LAW

Any offense against these house and site rules can be punished with an expulsion from the grounds. Any (administrative) or criminal behaviour will be reported to the responsible authorities without exception. For this purpose, the security service is entitled to collect the personal data of offenders. It is pointed out that a violation of the duties to act and to refrain imposed in these house rules is punishable according to § 35 Abs 1 of the current version of the Viennese Event Venue Act (Wr. VeranstaltungsstättenG), LGBI. Nr. 4/1978 in connection with § 32 Abs 3 of the current version of the Viennese Event Act (Wr. VeranstaltungsG), LGBI. Nr. 12/1971.

Pursuant to § 35 Abs 4 of the current version of the Viennese Event Venue Act (Wr. VeranstaltungsstättenG), LGBI. Nr. 4/1978, persons who do not submit to these approved and posted house and site rules may not be on the premises.

AUTHORITY TO ISSUE ORDERS

AUTHORITY TO ISSUE EXECUTIVE ORDERS; FIRE BRIGADE; SECURITY PERSONNEL, EXECU-TIVE BODIES OF THE CITY OF VIENNA, LANDOWNERS, LAND MANAGERS AND PROMO-TERS VIS-À-VIS VISITORS

Visitors must immediately follow possible orders issued by the executive branch, the fire brigade, the security personnel, the organs of the City of Vienna, the land owner, the land administrator and the organiser. In the event of non-compliance, the person concerned can be to the terrain. In the event of non-compliance, the person concerned may be removed from the premises.

All persons who enter the premises shall behave in such a way that other persons be neither harmed nor endangered or harassed. Furthermore, they must behave in such a way that there is no risk of damage to superstructures, equipment, devices or objects.

APPROVAL

The present house and site rules were issued by the organiser and the owner of the property and approved by the corresponding Magistrate's Department.

APPENDIX TERMS OF USE

LIABILITY

ENTERING THE SITE AT ONE'S OWN RISK

Entering the premises is at the visitor's own risk. Parents are responsible for their children. Events bear the risk of hearing damage due to high volume. The organiser assumes no liability for any damage that may occur.

In any case, use is at your own risk.

In the event of cancellation of an event, postponement or changes in the program or cast, there will be no reimbursement of expenses (e.g. travel expenses, hotel). Accidents and damages are to be reported immediately to the organiser, the security service or the emergency services of the blue light organisations.

UTILISATION RIGHTS

Any person entering the premises agrees that audio and video recordings may be produced free of charge and made us of using direct or deferred video display, direct or deferred transmission or other transmission or recording, photographs or other current and/or future media technologies free of charge.

Any person entering the premises acknowledges that they may only make audio and/or video recordings for private use. In any event, it is strictly prohibited to transmit sound and/or visual material in whole or in part or to assist others in carrying out such activities via the Internet, radio, television or other present and/or future media. Excluded from this are representatives of the press and electronic media who have been accredited by the organiser. The distribution of self-recordings as well as those of third parties with their consent in social networks is permitted.

In the case of TV broadcasts and other recordings, the visitor gives their consent to the transmitting TV broadcaster that the recordings made of them during or in connection with the event may be used without compensation and without time or space restrictions using any technical process.

The Vienna Police Headquarters informs that image and sound recordings will be made to prevent and ward off dangerous attacks against life, health or property of people. (Legal basis § 54 para. 5 SPG).

ADVERTISING ACTIVITY

The distribution and keeping available of printed matter, advertising material and/or disposable products is prohibited without the written permission of the organiser. In the event of non-compliance, the organiser is entitled to charge cleaning costs of \notin 1,800.00 in any case, a usage fee of \notin 2,400.00 in any case and the costs of legal intervention both against the person responsible on site and against the advertised person. Any further claims remain unaffected.
